



MUTT LIFE FOSTER AGREEMENT

This Foster Agreement is made and entered into this _____ day of _____ of this year _____ by and between Mutt Life Dog Rescue of Wisconsin Inc., hereinafter referred to as "Mutt Life," and the following individual(s), hereinafter referred to as "Foster." This agreement is holds binding for any and all future dogs fostered for Mutt Life, even if there is a gap between fostering.

For good and valuable consideration, the parties to the agreement agree as follows:

Foster will provide compassionate and loving care for the dog taken into the home for as long as necessary until the animal has been successfully placed into a permanent home. This care includes, but is not limited to, providing adequate food, water, shelter, and medication when required.

_____ Foster acknowledges an adjustment period for the dog and agrees to exercise patience and tolerance during this period.

_____ Foster commits to engage in basic training, such as housebreaking, socialization and enrichment, and refrains from harsh training methods like choking or striking.

_____ The dog is to reside indoors and should not be left unsupervised outside (including chained or fenced) for extended periods of time. If Foster lacks a fenced yard, the dog will be taken outdoors on a leash regularly.

_____ Foster will ensure the dog wears a securely fitted collar with proper Mutt Life identification tag on collar at all times.

_____ Foster will promptly inform Mutt Life of any signs of illness in the dog while fostering, seeking medical attention only as directed by Mutt Life. In the event of an inability to contact Mutt Life, Foster will leave a detailed message regarding the dog's symptoms.

_____ Foster shall not authorize any veterinary treatments, procedures, or medications without Mutt Life's consent. Any and all unauthorized medical treatments will be at the sole expense of the Foster.

_____ In the event that behavioral issues arise with the dog while fostering, Foster agrees to promptly notify Mutt Life and cooperate in addressing said issues.

_____ Foster will administer any scheduled or preventative medications as instructed by Mutt Life.

_____ Foster agrees to prevent unfamiliar people or animals from approaching the dog without proper control and introduction.

_____ Foster acknowledges that Mutt Life is the sole owner of the dog and accepts this. Foster also understands that they do not have the right or authority to keep the dog or place it in other homes or with other individuals. Any action involving moving the dog or placing it in a permanent home can only be done with the full knowledge and approval of Mutt Life.

_____ Foster understands and accepts Mutt Life's disclaimer of representations or warranties regarding the dog's health, temperament, behavior, and previous ownership.

_____ Foster will work cooperatively with Mutt Life to find the dog a permanent, loving home as quickly as possible. If Foster decides they would like to adopt the dog, they understand and accept that the procedure for adoption will be the same for them as it would be for any other applicant. Foster will be asked to sign the same contract and pay the same fee to Mutt Life as any other adopter. Foster understands and accepts that they may not keep the animal without the approval and consent of Mutt Life.

_____ Foster assumes full responsibility for any damages or injuries caused directly or indirectly by the dog while under Foster's care. This includes any and all manner of actions and causes of actions, suits, debts, dues, accounts, bonds, covenants, agreements, judgements, claims, and demands whatsoever arising from or relating to the adoption, placement, and/or possession of the dog.

_____ Foster acknowledges that Mutt Life has the right to terminate any foster arrangement at any time if they feel it is in the best interest of the dog.

By signing this agreement, the Foster(s) agrees that he/she has read and understands the above and agrees to abide by all of its provisions. Mutt Life may reclaim the dog, if in their judgment the dog is not being cared for properly, or if in Mutt Life's sole discretion, it is determined that the Foster has not complied with the terms of this agreement.
